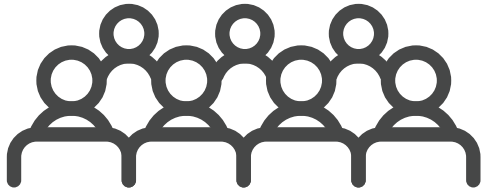

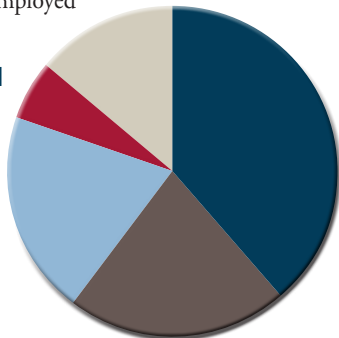
CLASS OF 2023 EMPLOYMENT OUTCOMES
