## **2013 William Pincus Award**

The Clinical Section's Executive Committee, upon the recommendation of the Section's Awards Committee, has chosen **Georgetown Professor Philip G. Schrag** as the recipient of the 2013 William Pincus Award for outstanding contributions to the cause of clinical legal education. The award will be presented at the Section's luncheon on Saturday, January 5<sup>th</sup> at the AALS Annual Meeting in New Orleans.

The following is a brief synopsis drawn from the Awards Committee's report:

From the earliest part of his career, Professor Schrag has confronted and overcome the problems inherent in the design of clinical programs. His work at Columbia Law School in the 1970's reflects experimentation in clinical models that were new and untested at the time, including large test case litigation and outreach from Columbia to the Harlem office of the Legal Aid Society of New York. At Georgetown, Professor Schrag created the Center for Applied Legal Studies ("CALS"), a clinical program that has handled social security disability cases, consumer protection cases and (since 1995) asylum cases. Beginning at Columbia and continuing at Georgetown, Professor Schrag become an advocate for the non-directive style of supervision in small case



clinical teaching that now represents a dominant model of clinical supervision. He has served as a mentor to an entire generation of clinical professors.

Professor Schrag also advocated effectively for improving the status of clinicians at Georgetown, leading ultimately to parity in salary and governance between clinicians and nonclinical faculty and the conversion of clinicians to tenured status. Finally, Professor Schrag successfully advocated for credit allocations for clinical programs that more accurately reflect the work required in an intensive clinical environment.

Professor Schrag's scholarship covers an enormous range and diversity of topics. Professor Schrag has also had an enormous impact on the ability of law students to sustain a career in public interest law, through his advocacy on federal loan forgiveness with the U.S. Congress.

Professor Schrag's remarkable contributions to the advancement of justice include writing the prevailing brief in the United States Supreme Court case that ended the practice of prejudgment wage garnishment. *Sniadach v. Family Finance Co.*, 395 U.S. 337 (1969). He drafted New York City's Consumer Protection Law, one of the strongest municipal laws in the country. He worked on arms control, serving at one point as legal counsel to the U.S. delegation to the negotiations for a comprehensive nuclear test ban treaty. With Professor Michele Pistone, he successfully blocked Congressional enactment of a 30-day statute of limitations on asylum applications.

The **Section on Balance in Legal Education** will present a program of likely interest to many clinicians during the AALS Annual Meeting on January 4 at 2-5 p.m. The first 90 minutes will focus on innovative educational approaches, including progressive methods at the newest AMA approved medical school in the U.S., and the George Washington Law School innovation to the first year to generate professionalism and career direction. We will also present snapshots of the newest research contrasting the impacts on attorney well-being of high income, motivation, service values, and other psychological factors. The second 90 minutes will feature a diverse cross-section of classroom strategies to generate engagement and enjoyment in students.

#### AALS Annual Meeting: *The Debt Crisis and the National Response: Big Changes or Tinkering at the Edges?*

The sections on Clinical Legal Education and Poverty Law will present a Joint Program at the AALS Annual Meeting on Saturday, January 5 at 10:30 a.m. The program will explore ways in which our clients and communities have experienced the national debt crisis. Panelists will bring a diverse range of experiences and expertise to the topic as they consider the response of courts and clinics to the crisis, as well as the impact (or lack of impact) of new and proposed federal and local regulations on some of the major debt-related issues. Panelists include the Honorable Fern A. Fisher, Deputy Chief Administrative Judge of the New York City Courts and Director of NYS Access to Justice Program, a leader in strengthening court procedures to protect consumers from abusive collection litigation; Clinical Professor Judith Fox, who directs the Economic Justice Project of the Notre Dame Legal Aid Clinic where she and her students represent clients at the center of the debt crisis; Dalie Jimenez, of the University of Connecticut School of Law, who was selected from the Call for Papers for her work as part of a team of faculty, students, social scientists and lawyers working on a long-term study to evaluate the effect of specific types of intervention on consumers sued to collect credit card debt; Professor Nathalie Martin of the University of New Mexico School of Law, whose recent research considers the impact of predatory lending products on client communities and whose clinic work includes representation of homeowners in foreclosure; and Professor Patricia McCoy, an expert in financial services regulation at the University of Connecticut School of Law, who recently served at the Consumer Financial Protection Bureau where she oversaw the CFPB's mortgage policy initiatives. Joint program co- chairs Mary Spector of SMU Dedman School of Law and **Jessica Steinberg** of The George Washington University Law School will moderate the program. Selected papers will be published in Georgetown Journal on Poverty Law and Policy.

The **Transactional Committee** held a productive meeting during the AALS Clinical Conference in LA (April 2012). We will meet during the AALS Annual Mtg in New Orleans (Jan. 2013) and at the Clinical Conference in Puerto Rico (April 2013). In January we will discuss launching a survey project to assess the impact of transactional clinics on former clinic students. # NEWS FROM THE CLINICAL WORLD

**The Lisa Foundation Patent Law Clinic at the Arizona State University / Sandra Day O'Connor College of Law** has been accepted into the USPTO's Patent Law School Clinic Certification Pilot Program and its Trademark Law School Clinic Certification Pilot Program, which will allow law students to represent clients, under faculty supervision, on issues related to their applications before the USPTO. Schools selected for participation in this program are chosen because of their exemplary intellectual property curricula, effective outreach to inventor communities, and comprehensive client services.

**The Natural Resources Law Clinic at the Arizona State University** / **Sandra Day O'Connor College of Law** began operation this fall (2012) under the direction of **Professor Joseph Feller**. The clinic combines legal representation of clients with readings and classroom discussions of current developments and issues in natural resources law that are closely related to our cases. Our clients are individuals and non-profit organizations concerned with conservation of natural resources and protection of the environment. Cases in our first semester have comprised state and federal administrative proceedings concerned with groundwater conservation, endangered species protection, and public rangeland management.

In the fall, several clinical programs at **CharlotteLaw** moved into new offsite loft space in the west Charlotte community. **Clinic Director Carol Turowski** was on hand to oversee the move which expanded clinical opportunities and doubled the size of clinic space for students, faculty and staff. The clinic programs at the new site include Community and Economic Development, Entrepreneurship, Family Advocacy, Tax Controversy, Domestic Violence, Criminal Justice (spring 2013), Immigration Law (spring 2013). Also housed at the new location is the Innocence Project at CharlotteLaw, the Access to Justice Law Journal, the Neighborhood Advocacy Cen-

ter (501(c)(3)) and the Small Practice Center, an incubator program which supports recent graduates interested in starting their solo or small firm legal careers.

The **Georgetown Juvenile Justice Clinic**, along with the Campaign for the Fair Sentencing of Youth, sponsored the 2012 National Convening of juvenile justice advocates on November 15 and 16, 2012 to share litigation and other advocacy strategies, build relationships, and move forward to implement the Supreme Court's decision in *Miller v. Alabama* which abolished mandatory life without parole for children.

Under the supervision of **Professors Vanessa Merton and Jason Parkin**, the Pace Law School Immigration Justice Clinic ("IJC") has been very active in learning how lawyers respond

to sudden if not entirely unexpected developments in the law that generate large numbers of confused, concerned potential clients who <u>think</u> that they should take advantage of the opportunities, but need help figuring out their options and making decisions. This fall's extension of Temporary Protected Status ("TPS") for Haitians present in the United States since the deadly

earthquake of 2010, in conjunction with President Obama's authorization this summer of "Deferred Action for Childhood Arrivals" ("DACA") – often erroneously referred to as "DREAMER" relief -- presented the IJC with an imperative

to create and offer large-scale, broad-based community education programs, coordinated and collaborated on with a multitude of civic organizations; educational, religious, and health care institutions; and local government offices and agencies.

The Truancy Court Program of the **University of Baltimore Center for Families Children and the Courts** has received unprecedented funding for the 2012-2013 school year. Funders include the Maryland Administrative Office of the Courts, the Governor's Office of Crime Control and Prevention, the Crane Family Foundation, the Zanvyl and Isabelle Krieger Fund, and AT&T. The TCP has expanded to include ten public schools.

The American Bar Association (ABA) presented the **University of Maryland School of Law Environmental Law Clinic** the 2012 Award for Distinguished Achievement in Environmental Law and Policy during the ABA Annual Meeting in Chicago. The Award is given to a U.S. bar association, law school clinical program, non-profit institution, non-profit legal services program, law firm, or government program that provides representation, education or advocacy on environmental matters that directly result in significant improvements in the substance, process or understanding of environmental law or policy. The Clinic, led by **Director Jane F. Barrett**, is the largest provider of pro bono environmental representation in Mary-land and works to improve and enforce environmental laws and regulations in the Chesapeake Bay region to protect air and water quality.

Enrolling its first students in January 2013, the Entrepreneurship Legal Clinic at the

**University of Nebraska College of Law** will offer an experiential learning opportunity to third-year law students interested in transactional law. The mission of the is to assist clients from the university, Lincoln, and communities all across Nebraska with basic legal needs arising in connection with starting new businesses. **Professor Brett Stohs** joined the faculty at the College of Law in March 2012 to establish and direct the activities of the Entrepreneurship Legal Clinic.

**University of St. Thomas Law** launched two new appellate clinics in the fall of 2012. One clinic, supervised by **Professor Gregory Sisk**, collaborates with students at the University of Arkansas under the supervision of **Assistant Professor Dustin Buehler** to represent indigent litigants before the 9<sup>th</sup> Circuit Court of Appeals. **Adjunct Professors Ben Casper** and **Kate Evans** supervise the 8<sup>th</sup> Circuit Immigration Appeals Clinic. Both clinics recently filed briefs and are looking forward to the opportunity of oral arguments in the spring.

The Entrepreneurial Law Clinic (ELC) at the University of Washington

**School of Law** has been selected by the United States Patent and Trademark Office (USPTO) to participate in both the Trademark Law School Clinic Certification and Patent Law School Clinic Certification Pilot Programs. ELC students will be able to draft and file trademark and patent applications as well as engage in other practitioner functions. In addition to this new development, in the past year, under **Managing Director Jennifer S. Fan**, the 19 JD, LLM and MBA students of the Clinic have served 30 ventures.

After returning from advisory meetings in Indonesia to assist new clinical law professors from

eight Indonesian law schools, **Professor Kim Ambrose** is now leading the supervision of the clinical work of four of these professors. They are attending the **University of Washington Law School** as part of a multi-year, USAID funded, E2J Project (Equipping Tomorrow's Justice Reformers). Enrolled in the LLM program, these professors are focusing on teaching clinical legal education and are participating as students in some of the eleven clinics at UW Law. After completing their LLM degrees they will return to their respective universities in

Indonesia and teach new clinics that focus on environmental, anti-corruption, women, children and criminal issues.

The **Appellate Advocacy Clinic** at **Wake Forest Law** is a two-semester course for 3Ls directed by **Professor John Korzen**. This year the clinic has ten students and six appeals, including four in the Fourth Circuit, one in the Eleventh Circuit, and one in the North Carolina Supreme Court. Two of the clinic's students have argued in the Fourth Circuit this semester. On September 18, Morgan McCall argued in *Estep v. Ballard*, a habeas case that originated in West Virginia state court. On October 25, Mary Beth Usher argued in *United States v. Fugit*, where the issues are whether a conviction for enticement of a minor to engage in sexual activity requires physical contact, and whether Fugit's trial counsel provided ineffective assistance of counsel by advising Fugit to plead guilty to the charge.

The **Civil Rights, Community Justice & Mediation Clinic** at **Washington University** was recently successful in getting St. Louis County to adopt an ordinance providing for mandatory mortgage loan foreclosure mediation and also successful in defeating a court challenge to the ordinance. Several clinic students played key roles throughout the process -- initial research on the foreclosure problem across the country, drafting the ordinance, media and lobby-ing efforts, negotiations on amendments to the ordinance, and research on motions for a TRO and summary judgment.

The Clinical Law Review seeks applications for two vacancies on the Board of Editors and for the position of one of the three co-Editors-in-Chief. The Board of Editors urges you to think about whether you would be interested, and to think about others whom you would encourage to apply.

Members of the Board of Editors serve for a term of 6 years. The term of the new Board members will commence in January 2014. Board meetings customarily are held twice a year: once at the annual Clinical Law Review Workshop at the end of September and once at the AALS Spring clinical workshop or conference. 
