- This course is offerred as a one-credit, pass/fail seminar. All students who enroll in this course must also enroll in Legal Externship to obtain two or three credits for fieldwork. Students who are enrolling in their first externship for credit must enroll in one of the Becoming a Lawyer seminars during the same semester as the fieldwork.
- Students enrolling in their first externship should register for 2 or 3 credits of Legal Externship and must also enroll in one of the Becoming a Lawyer seminars. Students in their second or greater externship should only register for 2 or 3 credits of Legal Externship. "Second or greater" students will be required to meet with the Experiential Learning Director twice during the course of the semester. Prior to registering for Legal Externship credits, students must complete the online Legal Externship Placement Approval Form. Please see the Legal Externship website for details. Once your externship is approved, you will be given permission within Cardinal Students to register for

the 2 or 3 credit Legal Externship.

- This course fulfills a portion of the Experiential Learning Requirement.
