JUDICIAL CLERKSHIP OPINION WRITING CONFERENCE

Three years ago, The Columbus School of Law at The Catholic University of America initiated its Judicial Clerkship Opinion Writing Conference, a unique event focused solely on opinion writing and open to individuals who have accepted an upcoming federal clerkship (district court or court of appeals) or state appellate court clerkship.

Over the course of the conference, conferees have received instruction from some of our nation's most distinguished members of the judiciary and bar, including judges from six different federal circuits courts, seven federal district courts, the court of federal claims, and seasoned practitioners in governmental and private practice.

In addition to instructional lectures, ethics panels, and general Q&A sessions on chambers protocol, the conferees are also guided through writing an appellate court opinion and receive individual review and commentary on their work.

Finally, each of the conferees is eligible for the CSL Prize in Judicial Clerkship Opinion Writing, judged by the conference faculty. The opinions drafted and submitted by the conferees involve First Amendment issues tied to the school's other First Amendment Initiatives, about which information can be found here: <u>https://www.law.edu/academics/First_Amendent_Initiatives_Program.html</u>

Since its inception, the cohort of conferees has grown to thirty-five, with a waitlist equal to that number populating within only a few weeks of the October call for applications. The accepted conferees are provided with transportation to D.C. and accommodations for a two-night stay, as well as a Welcome Reception/Dinner and meals throughout the duration of the events.

The three day-event has thus far brought nearly one hundred rising clerks to our campus—from as far away as Hawaii and as close by as D.C.—and from schools that include Harvard, Notre Dame, Berkeley, Cornell, Penn State, Vanderbilt, Virginia, Georgetown, and UCLA, to name only a few.

As this is a singular enterprise in legal education—one providing critical instruction to some of the best among the nation's future practitioners—we hope that you will consider this opportunity to partner with us in this way, or on any of our First Amendment Initiatives.
