In addition to assisting the Curriculum Committee and faculty with redesigning the writing program, the Director will teach in the research and writing program, oversee the hiring and training of writing faculty, create syllabi and assignments for the required writing courses, and assist the writing faculty in structuring class sessions. The Director will work closely with the Director of the Law Library and will report to the Associate Dean for Academic Affairs.
